24/504 Minutes of the last meeting

The minutes of the last meeting were unanimously approved

Meeting suspended to take questions or comments from the Public

Member of Public – Applicant of planning app @ Smithwick's Lane, have spoken to neighbours RE concerns around flooding and extra runoff. Water harvesting is planned to contain most runoff. Searches have shown to be outside flood concern areas. Discussion over exact location was heard; screening of the barn is a part of discussions with the forestry commission, lots of trees planned. Extra hardstanding is well under half of permitted allowance per planning regulations.

Member of Public – Congregational chapel planning has been very slow – involved MP and lawyers and finally there is some movement and agreement from planning and conservation, however Historic England have raised 5 objections – carparking, interruption of planned form, removal of pews, too many fireplaces... Has been a rebuttal – has been no car parking for 2 years, planned form is being retained, pews are staying and being reused, fireplaces already exist and stack will be reinstated. Only one statutory consultee is recommending refusal, will wait and see outcomes.
